## **iSTAR Medical haalt 40,1 miljoen EUR op in een financieringsronde die wordt geleid door Gimv ter ondersteuning van de verdere ontwikkeling van een innovatieve glaucoombehandeling.**

iSTAR Medical SA, een in Waver gevestigde onderneming voor medische technologie die nieuwe oogheelkundige implantaten ontwikkelt voor de behandeling van glaucoom, kondigt vandaag de voltooiing van een serie C-financieringsronde van 40,1 miljoen EUR aan. Deze ronde, geleid door Gimv en LSP (Life Sciences Partners), werd mee onderschreven door Earlybird en BNP Paribas Private Equity. Gimv zal in het totaal 10 miljoen EUR investeren. Ook de bestaande aandeelhouders Capricorn Partners, SRIW en SFPI-FPIM namen deel. Deze financieringsronde ondersteunt de verdere ontwikkeling van iSTAR Medical voor de commercialisering van zijn MINJect-implantaat in Europa en de VS.

iSTAR Medical (<https://www.istarmed.com>) werd opgericht in 2011 als medisch bedrijf dat zich richt op de ontwikkeling van nieuwe oogheelkundige implantaten voor patiënten met glaucoom. Glaucoom – gekenmerkt door een toename van de intraoculaire druk – treft wereldwijd meer dan 92 miljoen mensen en is de tweede belangrijkste oorzaak van blindheid bij volwassenen. Micro-invasieve glaucoomchirurgie (MIGS) is de meest veelbelovende en snelst groeiende therapeutische optie bij de behandeling van glaucoom. iSTAR Medical's MINJect, een ab-interno MIGS-implantaat, biedt een krachtige en betrouwbare oplossing om de intraoculaire druk veilig te verminderen door een verbeterde vochtafdrijving uit de voorste oogkamer naar de supraciliaire ruimte, en is ontworpen als een *best-in-class* MIGS-implantaat. In tegenstelling tot andere technologieën, gebruikt MINJect het innovatieve STAR®-materiaal, een zacht en flexibel silicone van medische kwaliteit bestaande uit een microporeuze matrix met meerdere afvoerkanalen.

Bram Vanparys, Partner binnen het Health & Care platform van Gimv, over deze transactie: *“We kijken ernaar uit om iSTAR Medical te helpen om de leidende speler op het gebied van MIGS te worden. ## iSTAR Medical announces EUR 40m Series C Financing

***To accelerate development and commercialisation of innovative Glaucoma MIGS device, MINject™***

**WAVRE, Belgium — 5 September 2019:** iSTAR Medical SA, a private medical device company developing novel ophthalmic implants for the treatment of glaucoma, today announced the completion of a €40m Series C financing. The financing was led by healthcare specialist funds LSP and Gimv, with participation by Earlybird and BNP Paribas Fortis Private Equity. Existing shareholders including Capricorn Partners, Walloon Region Investment Fund (SRIW) and Belgian Federal Investment Fund (SFPI-FPIM) also participated. This financing will support the development of iSTAR Medical's MINject™ device along the path to commercialisation in Europe and the United States.

Glaucoma is the second leading cause of adult blindness globally affecting more than 92 million people. Micro-invasive glaucoma surgery (MIGS) is the most promising and fastest-growing therapeutic option in the treatment of glaucoma<sup>1</sup>.

MINject, an ab-interno MIGS device, provides a powerful and reliable solution to safely reduce intraocular pressure (IOP) by enhancing aqueous humour outflow from the anterior chamber to the supraciliary space, and has been designed to be a best-in-class MIGS device. Unlike other technologies, MINject uses the innovative STAR® material, a soft and flexible, medical-grade silicone with a micro-porous, multi-channel geometry.

Data from the first-in-human [STAR-I trial](#) for the MINject device in a standalone setting confirm that MINject is safe and highly effective in achieving significant IOP reduction, as well as easing medication burden in glaucoma patients.

**Michel Vanbrabant, CEO of iSTAR Medical, commented:** *"iSTAR Medical is setting new frontiers in MIGS treatment of glaucoma. The positive results achieved at 18-month follow-up of our first-in-human trial validates the potential of MINject in the supraciliary space as the next therapeutic option for glaucoma patients. This financing is a significant milestone for the company and will support the development and commercial launch of MINject."*
